WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that **“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;**

WHEREAS, Rule IX, Article 47(a) of the Rules and Regulations Implementing Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides that, **“unless otherwise provided in the Code, no contract maybe entered into by the Local Chief Executive in behalf of a Local Government without prior authorization by the Sanggunian.”;**

WHEREAS, Save the Children Philippines (SCP), Inc., a non-stock, non-profit organization duly registered under Philippines Laws, with principal address at 4th Floor Sunnymede IT Center, Quezon Avenue, Quezon City;

WHEREAS, the Save the Children Philippines (SCP) Inc., donated one (1) unit of laptop, one (1) unit of mouse, and two (2) units of tablets within the City of Muntinlupa to be used exclusively for recording in the Digital Information System For Health (DISH);
