A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE VETERAN'S BANK (PVB) REPRESENTED BY ITS SENIOR MANAGER AND BRANCH BANKING GROUP-SOUTH METRO MANILA AREA HEAD, MIRELLA S. WHEREAS, Section 458 of Republic Act 7160 otherwise known as the Local Government Code (LGC), "*The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants pursuant to general welfare and in the proper exercise of the corporate powers of the city as provided for under section 22 of the LGC shall, approve ordinances and pass resolutions necessary for an efficient and effective city government;*"

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC, provides that, *for efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants, the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;*

WHEREAS, the Bureau of Local Government Finance Memorandum Circular No.07-01-2017 provides that, "LGUs specifically allowed by law, rules and regulations to retain income and/or for operations and/or working balances, shall deposit and maintain Government Funds with any of the following banks:

Xxx

f. Philippine Veterans Bank authorized to accept funds from the LGUs and subject to limitations prescribed by the Monetary Board.

WHEREAS, the PVB proposed to the City Government of Muntinlupa (CGM) the following:

- 1) **Payroll facility and Services for CGM employees specifically hazard pay of personnel in the offices of City Health and City Veterinary, as well as repository of regular allowances for personnel in the Muntinlupa stations of Philippine National Police and Bureau of Fire Protection;**
- 2) **The provision of one (1) lobby type Automated Teller Machine (ATM) to be located along Centennial Avenue, Barangay Tunasan, Muntinlupa City;**

WHEREAS, finding that the proposal will contribute to the convenience, efficiency and ease of banking transaction not only for the city employees but also of the general public, and after the terms and conditions of the memorandum of agreement were reviewed by the City Legal without objection, the City Government accepted the same;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **City Mayor Hon. Rozzano Rufino B. Biazon** to enter into a **Memorandum of Agreement (MOA)** with the **Philippine Veteran's Bank (PVB)** represented by its Senior Manager and Branch Banking Group-South Metro Manila Area Head, **Mirella S. Valverde** and Manager PVB Muntinlupa Branch Head, **Portia Samano** on the **Payroll Facility and Services for Hazard Pay of Specific City Government Employees, Benefit Payment to Muntinlupa-Stationed National Offices Personnel** and the provision of **One (1) Lobby Type Automated Teller Machine (ATM)** to be located along Centennial Avenue, Barangay Tunasan, Muntinlupa City.

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **21st** day of **November 2022**, on its **20th Regular Session**.


