WHEREAS, Section 455 (b)(1)9(vi) of the Local Government Code provides that, *the City Mayor shall exercise such powers and performs functions for efficient, effective and economical governance the purpose of which is the general welfare of its inhabitants pursuant to Sec 16 of RA7160, the city mayor shall represent the city in all business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod*";

WHEREAS, Section 455 of Republic Act 7160 of the Local Government Code (LGC) of 1991, empowers the city mayor, as chief executive of the city government, to exercise such powers and perform such duties and functions for efficient, effective and economical governance the purpose of which is the general welfare of the city and its inhabitants;

WHEREAS, Landbank, one of Muntinlupa City Government's depository bank, offered the weAccess which is an internet banking facility developed for the bank's institutional clients, both private corporations and government entities. The system offers fund management, bills payment, remittance services, and automated teller machine (ATM) payroll services, among others;

Lambino**, in line with the online banking platform that provide convenient, reliable and secure delivery of banking services.
