**WHEREAS**, jiu-jitsu is a family of Japanese martial arts and a system of close combat (unarmed or with a minor weapon) that can be used in a defensive or offensive manner to kill or subdue one or more weaponless or armed and armored opponents. Jui-jitsu has evolved into many forms however the same principle of yielding to an opponent's force rather than trying to oppose force with force is being applied;

**WHEREAS**, on November 11, 2022, a Muntinlupeno kid bagged the gold medal in the Kids 1 Girls White Belt 16kg-B category at the Abu Dhabi World Jiu-Jitsu Festival and at age of five (5), became the youngest champion of the martial arts;

**WHEREAS**, at her tender age, **Aleia Aielle Aguilar**, imbued the discipline being taught in jui-jitsu, that of humility, hard work and patience, qualities which aid her in beating her opponents;

**WHEREAS**, Aleia is the youngest daughter of Alvin Aguilar, considered a pillar in the country's mixed martial arts community, and former jiu-jitsu champion Maybelline Masuda, the first Filipino jiu-jitsu world champion in 2009 and recipient of the country's first gold in the sport in the 2014 Asian Beach Games;

**NOW THEREFORE RESOLVE AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to grant recognition to Aleia Aielle Aguilar, the Youngest Jiu-Jitsu World Champion in the 2022 Abu Dhabi World Jiu-Jitsu Championships.
