WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC (LGC-IRR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

**WHEREAS**, City Legal Office has no objection to the issuance of Resolution from the Sanggunian giving authority to the Chief Executive to sign the MOA;

**WHEREAS**, Eurolink is an independent contractor and third party Electronic Claims (eClaims) Health Information Technology Provider (HITP) duly accredited and licensed by PHILHEALTH to access PHILHEALTH eClaims;

**WHEREAS**, City Government of Muntinlupa thru **Muntinlupa Reproductive Health & Wellness Clinic (MRHWC)** required the by PHILHEALTH to utilize its eClaims thru Eurolink;

**WHEREAS**, Eurolink has created its own Hospital Information System (HIS) for the process and payment of City Government of Muntinlupa's (**Muntinlupa Reproductive Health & Wellness Clinic (MRHWC)**) patients benefit claims;

**WHEREAS**, City Government of Muntinlupa's (**Muntinlupa Reproductive Health & Wellness Clinic (MRHWC)**) pursuant to PHILHEALTH's mandate for all its accredited Health Care Institutions to connect its claims framework, engage the services Eurolink to provide its HCl's with Easy Claims and Type of Integration applicant's software;

**WHEREAS**, as provided under the MOA any outstanding and unpaid fees after the agreement, number of days stated under the agreement shall earned interest at the rate of **5% per month** based on the outstanding amount due and payable inclusive of interest earlier imposed, if any;

**WHEREAS**, the services to be undertaken and performed by Eurolink under or pursuant to this agreement shall include services set out in the MOA of Services, the services shall include the following:

i. Easy Claims (eClaims) Software:

1. **Claim Eligibility Web Service (CEWS);**
2. **Electronic Claim Submission (ECW);**
3. **Electronic Claim Status Verification (CSV);**

ii. Easy Claims (EClaims) and type of Integration Application Software

**WHEREAS**, the City Government of Muntinlupa's (**Muntinlupa Reproductive Health & Wellness Clinic (MRHWC)**) shall be charged the amount of Ten Pesos (Php10.00) for every claim submitted through Easy Claim inclusive of taxes;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Rozzao Rufino B. Biazon**, in behalf of the **Muntinlupa Reproductive Health & Wellness Clinic (MRHWC)** to enter into a **Memorandum of Agreement (MOA)** with **Eurolink Network International Corporation**, represented by its AVP for Finance, **Abigail Ong**, on the exclusive engagement of the City Government as **eClaims Health Information Technology Provider (HITP)** in the benefit claims transactions for Philhealth for the CGM's **Outpatient HIV/AIDS Treatment Package (OHAPT)**.






