Contract Agreement

THIS AGREEMENT, is made this ___day of ____, 2023 between the **CITY GOVERNMENT OF MUNTINLUPA** (hereinafter, the "Entity"), with address at City Hall, National Road, Putatan, Muntinlupa City, and **UPLINK INTEGRATED SOLUTIONS INC.** (hereinafter, the "Supplier"), with address in Calamba, Laguna.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz. **Expansion of CCTV Coverage in Muntinlupa City for the DDRM Operations Center** (*Re-posted) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of total amount of **Fourteen Million Five Hundred Ninety-Five Thousand Pesos (P14,595,000.00)** as hereinafter, the ("Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
