

Contract Agreement

THIS AGREEMENT, made this ____ day of _____, 2023 between **CITY GOVERNMENT OF MUNTINLUPA** with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the "Entity") and **V.F. LABAO CONSTRUCTION CORPORATION** with address at Taguig City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Installation of Fiber Optic Cable at BPLO, City Treasury, Satellite Office, MCMAO, Police Clearance, PDAO, MTMB, NBI, Ayala Mall Alabang, Muntinlupa City /9139004** (hereinafter called "the Works") and the Entity has accepted the Bid for **One Million Seven Hundred Ten Thousand Pesos (P1,710,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
- b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- In consideration for the sum of **One Million Seven Hundred Ten Thousand Pesos (P1,710,000.00)** or such other sums as may be ascertained, **V.F. 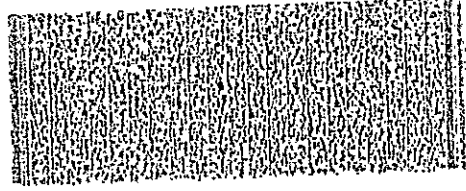
