THIS AGREEMENT, made this _____ day of ______, 2023 between CITY GOVERNMENT OF MUNTINLUPA with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the "Entity") and RS CIRCLE LINK CONSTRUCTION CORPORATION with address at Bacoor, Cavite (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Construction of Pet Crematorium at Pacwood Brgy., Tunasan** (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million Six Hundred Ninety-Eight Thousand Eight Hundred Eighty-Eight Pesos and 88/100 (P2,698,888.88)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
