_day JAN 1 0 2023 2022 between the CITY THIS AGREEMENT, is made this ___ GOVERNMENT OF MUNTINLUPA (hereinafter, the "Entity"), with address at City Hall, National Road, Putatan, Muntinlupa City, and MEGAFIXTURES INC. (hereinafter, the "Supplier"), with address in Quezon City.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz. Supply, Delivery & Installation of IP Surveillance Monitoring System at Plaza Central and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of total amount of Three Million Nine Hundred Forty-Nine Thousand Nine Hundred Pesos (P3,949,900.00) hereinafter, the ("Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
