## **Contract Agreement**

THIS AGREEMENT, is made this \_\_\_\_ day of FEB 15 2023, 2023 between the **CITY GOVERNMENT OF MUNTINLUPA** (hereinafter, the "Entity"), with address at City Hall, National Road, Putatan, Muntinlupa City, and **UPLINK INTEGRATED SOLUTIONS INC.** (hereinafter, the "Supplier"), with address in Calamba, Laguna.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz. **Supply & Delivery of Project Management & Monitoring System with Document Archiving for DDRM (\*Re-posted)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of total amount of **Five Million Five Hundred Ninety Thousand Nine Hundred Pesos (P5,590,900.00)** as hereinafter, the ("Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

- In consideration for the Sum of **Five Million Five Hundred Ninety Thousand Nine Hundred Pesos (P5,590,900.00)** as or such other sum that maybe ascertained, **UPLINK INTEGRATED SOLUTIONS INC.** agrees to the **Supply & Delivery of Project Management & Monitoring System with Document Archiving for DDRM (\*Re-posted)** in accordance with his/her/its Bid.
- The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.





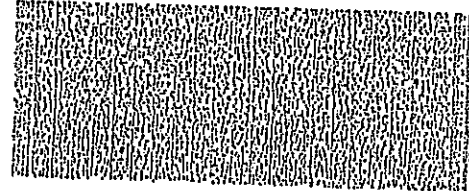
