#### Contract Agreement

THIS AGREEMENT, is made this \_\_\_\_day of FEB 15 2023, 2023 between the CITY GOVERNMENT OF MUNTINLUPA (hereinafter, the "Entity"), with address at City Hall, National Road, Putatan, Muntinlupa City, and UPLINK INTEGRATED SOLUTIONS INC. (hereinafter, the "Supplier"), with address in Calamba, Laguna.

WHEREAS, the Entity invited Bids for certain goods and ancillary services, viz. Supply & Delivery of Project Management & Monitoring System with Document Archiving for DDRM (\*Re-posted) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of total amount of Five Million Five Hundred Ninety Thousand Nine Hundred Pesos (P5,590,900.00) as hereinafter, the ("Contract Price").

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
