AN ORDINANCE GRANTING FIVE PERCENT (5%) ACROSS THE BOARD INCREASE IN THE MONTHLY SALARIES OF ALL QUALIFIED CITY EMPLOYEES, PURSUANT TO LOCAL BUDGET CIRCULAR NO. 74 DATED JUNE 15, 2001 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT EFFECTIVE, JULY 1, 2001.

WHEREAS, Local Budget Circular No. 74, dated June 15, 2001, authorizes the City Government to grant a maximum of 5% salary adjustment to its employees effective July 1, 2001 pursuant to Republic Act 9137, dated June 8, 2001;

WHEREAS, the employees of the city covered by this 5% across the board salary increase shall be those provided for in the implementing rules and regulations specifically sub-paragraph 2.1 of the Local Budget Circular, herein quoted:

"LGUs which have available funds for the purpose as contained in an appropriation ordinance may implement the salary adjustment in accordance with the rules and regulations, provided under the Local Budget Circular 9LBC) No. 69, dated March 21, 2000. For purposes of this Circular, all references to "December 31, 1999" and "January 1, 2000" under LBC 69 are hereby changed to "June 30, 2001" and "July 1, 2001", respectively."

WHEREAS, the City has an available budget from the salary savings;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, that 5% across the board salary increase in the monthly salaries of all qualified city employees, pursuant to Local Budget Circular No. 74 issued by the Department of Budget and Management, be granted effective July 1, 2001.
