WHEREAS, *Section 16 under "State Policies", of 1987 Philippine Constitution* states that, "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with rhythm and harmony of nature;

WHEREAS, *Section 458 (1) (VI) of RA 7160* otherwise known as Local Government Code of 1991, the Sangguniang Panlungsod is empowered to protect the environment and impose appropriate penalties for acts which endanger the environment ...and such other activities which results in pollution or of ecological imbalance;

WHEREAS, *Section 10 Chapter II of RA 9003*, known as Ecological Solid Waste Management Act of 2000 states among others, "Pursuant to the relevant provisions of RA 7160, the Local government Units (LGUs) shall be primarily responsible for the implementation and enforcement of the provisions of this Act (RA 9003) within their respective jurisdiction;

WHEREAS, *Section 12 Chapter II, of RA 9003*, known as Ecological Solid Waste Management Act of 2000 states that, "Each city or municipality shall form a City or municipal Waste Management Board that shall prepare, submit and implement a plan for the safe and sanitary management of solid waste generated in areas under geographic and political coverage;

WHEREAS, a ecological solid waste management, environmental protection and rehabilitation, as well as clean and green program are among the priorities of eight point program of governance of the city;

NOW THEREFORE, BE IT ORDAINED by the 3<sup>rd</sup> Sangguniang Panlungsod of Muntinlupa the following:

Section I. A City Ecological Solid Waste Management body shall be established to be known as "Muntinlupa Ecological Solid waste Management Board".

Section II. Composition of the Board: The "Board" shall be composed of the following:

- Chairman : City Mayor of Muntinlupa
  - Vice Chairman : Chairman, Committee on Health and Sanitation
  - Members:
    - a. Chairman, Committee on Environment, Aquatic, Fisheries and Natural Resources
    - b. President of the Association of Barangay Chairman
    - c. Chairman of the Sangguniang Kabataan Federation
    - d. Representative of each concerned Local Government agency or department such as:
      - 1. City Health Office
      - 2. Environmental Sanitation Centre
      - 3. Chairperson, Clean and Green
      - 4. DECS-Muntinlupa
      - 5. City Engineering
      - 6. City Planning Office
      - 7. Lake Management Office
      - 8. City Cooperative Office
      - 9. Department of Agriculture
      - 10. BPLO
      - 11. EPNRO
      - 12. Legal Office
      - 13. POSO/PNP
      - 14. DILG
    - e. Representative from NGOs whose principal objectives are to promote ecological solid waste management and protection of rehabilitation of the environment and preservation
    - f. A representative from Peoples Organization
    - g. A representative from recycling industry
    - h. A representative from the business sector (Muntinlupa City Chambers of Commerce and Industry)
- The Board, may from time to time, call on or invite any concerned agencies or sector as it may deem necessary.

**Section III : Technical Working Committee:** A Technical Working Committee is hereby created composed of the following:

- Chairman : Chairman, Committee on Health and Sanitation (City Council)
- Members : Environmental Sanitation Center  
City Planning Office  
City Health Office  
City Engineering Office

The Technical Working Group shall meet from time to time and recommend programs, projects, strategies and other activities for the approval of the Board.

**Section IV.** The Muntinlupa Ecological Solid Waste Management Board shall have the following duties and functions:

1. Develop the City's comprehensive and integrative ecological solid waste management plan, that shall ensure the implementation of the long-term management of solid waste, as well as integrate the various solid waste management plans and strategies of the barangays in its area of jurisdictions through consultations with the various sectors of the community.
2. Adopt measures to promote and ensure the viability and effective implementation of the Solid Waste Management Programs in its component barangays.
3. Monitor and evaluate the implementation of the City's Ecological Solid Waste Management Plans through its various political subdivisions, in cooperation with the private sectors, the NGO's and the People's Organization.
4. Adopt specific revenue generating measures to promote the viability of its Eco-Solid Waste Management Plan.
5. Develop the specific mechanics and guidelines for the implementation of the City's Ecological Solid Waste Management Plan,.
6. Convene regular meetings for purposes of planning and coordinating the implementation of the Ecological Solid Waste Management Plans of the respective component barangays.( once a month)

7. Review every two (2) years or as need arises the City's Ecological Solid Waste Management Plan for purpose of ensuring its sustainability, viability, effectiveness and relevance in relation to local and international developments in the field of solid waste management.
8. Recommend to appropriate local government authorities specific measures or proposals for franchise, or build operate-transfer agreements, foreign aids, grants or loans with duly recognized institutions, pursuant to RA 6957, to provide either exclusive or non-exclusive authorities for the collection, transfer, storage, processing, recycling, disposal of the municipal waste. The proposals shall take into consideration, appropriate government rules and regulations on contracts, franchise and build-operate-transfer agreements.
9. Review and recommend resolutions and ordinances to the Sangguniang Panlungsod and Sangguniang Pambarangay that will ensure enforcement and implementation of its waste management program.
10. Recommend measures and safeguard against pollution and for the preservation of the natural ecosystem.


**Section V. Effectivity.** This Ordinance shall take effect upon its approval.

**Section VI. Repealing Clause.** All ordinances or resolutions (such as Resolution No.99-063 creating Eco-Waste Management Board) inconsistent or deemed redundant with the provisions of this Ordinance shall be repealed accordingly.
