ORDINANCE NO. 01-011

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P3,000.00) TO EACH HOMEOWNER, TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, SHARER AND BOARDER OF THE HOUSES BURNED DUE TO FIRE ON SEPTEMBER 16, 2001 AT ZAPANTA COMPOUND, PUROK 1, BLOCK 6-C, BAYANAN, MUNTINLUPA CITY AND ALLOCATING A TOTAL AMOUNT OF SIXTY SEVEN THOUSAND PESOS WHICH AMOUNT SHALL BE TAKEN FROM THE 2001 EXECUTIVE BUDGET – CALAMITY FUND.

WHEREAS, Section 16, of the Local Government Code of 1991 states that "Every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, on September 16, 2001 at 8:30 p.m., thirty (30) houses were gutted by fire at Zapanta Compound, Purok I, Block 6-C, Bayanan, Muntinlupa City;

WHEREAS, the owners of the houses, renters/sharers/boarders, were rendered homeless by reason of the said fire;

WHEREAS, the Sangguniang Panlungsod of Muntinlupa has passed a Resolution No. 01-020 declaring Zapanta Compound, Purok 1, Block 6-C, Bayanan, Muntinlupa City as in a state of calamity;

WHEREAS, there is a need for the city government to give financial assistance to the aforesaid victims in the amount of Sixty Seven Thousand Pesos (P67,000.00) to be distributed as follows;

- 1. Homeowners - P3,000.00
- 2. Renters/Shares/Boarders - P2,000.00

WHEREAS, the Social Services Department of City of Muntinlupa has submitted a *certified copy* of the list of the homeowners, renters, sharers, and boarders in coordination with the Barangay Chairman of Bayanan;

WHEREAS, based on the official list submitted by the Social Services Department hereto attached as *Annex "A"*, there are seven (7) homeowners, seventeen (17) renters, and six (6) boarders affected by fire;

WHEREAS, Section 5 (a) of Rules and Regulations Implementing R.A 8185 states that, "*allocation – the 5% Calamity Fund shall be set aside as annual lump sum appropriation for every calendar year in the annual budget of the Local Government Unit (LGU) to be allocated to area affected by a disaster or calamity; LGUs may also allocate for the use of a portion of 5% Calamity Fund to other affected areas on condition that the said areas are declared as in a state of calamity by the Sangguniang Panlungsod.*"

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, to grant *Three Thousand Pesos (P3,000.00)* to every homeowner, *Two Thousand Pesos (P2,000.00)* to each renter/sharer and boarder of the houses burned due to fire on **September 16, 2001** in *Zapanta Compound, Purok 1, Block 6-C, Bayanan, Muntinlupa City*, and **allocating** a total amount of *Sixty Seven Thousand Pesos (P67,000.00)*, which amount shall be taken from the **2001 Executive Budget –Calamity Fund**.

APPROVED, by the *Sangguniang Panlungsod of Muntinlupa* this 20th day of **September 2001**, on its 7th Regular Session.


