ORDINANCE NO. 01-015

AN ORDINANCE REQUIRING OWNERS OF ALL VEHICLES RESIDING ALONG THE MAJOR THOROUGHFARES TO PROVIDE THEIR OWN GARAGE TO ACCOMODATE THEIR VEHICLE/S, AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Section 458 (5), (v) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod to approve ordinances which shall ensure the efficient and effective delivery of the basic services and facilities, and in addition thereto, shall:

(v) Regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places and approve the maintenance of the same; regulate garages and the operation of conveyances for hire; designate stands to be occupied by public vehicles when not in use;

(vi) Regulate traffic on all streets; prohibit encroachments or obstacles thereon and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal constructions in public places;

WHEREAS, in most cases, vehicles, when not in use, are usually parked on sidewalks or on both sides of the roads/streets, thus, causing heavy traffic especially during rush hours;

WHEREAS, these vehicles seen parking on sidewalks or on both sides of the roads/streets are excess number of vehicles of the owners who do not have enough space for garage to accommodate their vehicles;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panglungsod of Muntinlupa the following:

Section 1. DEFINITION OF TERMS:

- a. GARAGE- a place to house vehicle/s when not in use;
- b. MAJOR THOROUGHFARES- shall include the National Hi-way, East and West Service Road, Montillano St., Alabang-Zapote Road and all Provincial Roads of Muntinlupa City;

Section 2. This Ordinance requires all owners of vehicles who are residing along the major thoroughfares of the City of Muntinlupa to provide their own garage in order to accommodate their vehicle/s.

The Muntinlupa Traffic Management Bureau (MTMB) and Traffic Environment and Discipline (TED) and other persons who are duly authorized by the Local Chief Executive to enforce the City traffic ordinances are mandated by this Ordinance to monitor from time to time, and if necessary, tow and impound vehicles found violating the provisions of this Ordinance, after proper issuance of Ordinance Infraction Receipt (OIR) to the driver of said vehicles.

Section 3. ONE (1) YEAR MORATORIUM. Owners of the vehicles residing along the major thoroughfares, as herein defined, are hereby given one (1) year from effectivity of this Ordinance to provide their own garage.

Section 4. PENALTY CLAUSE. Owners of vehicle found violating the provisions of this Ordinance shall be penalized in accordance with the following:

- 1. FIRST OFFENSE - a fine of Five Hundred Pesos (P500.00) after issuance of Ordinance Infraction Receipt (OIR) to the owner of the vehicle or an imprisonment of five (5) days, or both, at the discretion of the court;
- 2. SECOND OFFENSE - a fine of One Thousand Pesos (P1,000.00) after issuance of Ordinance Infraction Receipt (OIR) to the owner of the vehicle or an imprisonment of ten (10) days, or both, at the discretion of the court;
- 3. THIRD OFFENSE - a fine of Three Thousand Pesos (P3,000.00) after issuance of Ordinance Infraction Receipt (OIR) to the owner of the vehicle or an imprisonment of one (1) month, or both, at the discretion of the court;

Aside from the fine and/or imprisonment imposed in the third offense, the MTMB/TED shall recommend to the LTO-LTFRB the revocation of the owner's registration or franchise route and driver's license, and the vehicle/s parked outside of the garage shall be towed by the accredited tow truck in the Impounding Area of the City and shall be imposed the corresponding towing and impounding fees, prescribed under City Ordinance No.01-14.


Section 5. **REPEALING CLAUSE.** All ordinances, rules and regulations which are inconsistent with this Ordinance shall be repealed or modified accordingly.

Section 6. **EFFECTIVITY CLAUSE.** This Ordinance shall take effect after publication in any newspaper of general circulation of the City.
