AN ORDINANCE AMENDING SECTION 8 "MUNTINLUPA HEALTH CARE PROGRAM", SECTION 9 "MGA AKREDITADONG OSPITAL AT KLINIKA", SECTION 13 "MGA KASALI SA PAGKAKALOOB NG MGA SERBISYO SA HEALTH CARE", SECTION 14 "HINDI KASAMA (EXCLUSION)" AND SECTION 18 "APROPRASYON" OF KAUTUSANG BAYAN BLG. 93-31.

WHEREAS, Kautusang Bayan Bilang 93-31 (Establishing Healthcare Program and Commission) was passed last August 2, 1993 for purposes of giving hospitalization and other healthcare benefits including funeral and burial expenses among others, to all officials and employees of the City of Muntinlupa including their legitimate dependents;

WHEREAS, for the past eight (8) years, the healthcare program had served its purpose of alleviating medical and financial problems in time of needs among the city government officials and employees of Muntinlupa;

WHEREAS, the City Government of Muntinlupa establishes its own Ospital ng Muntinlupa, a tertiary general hospital aims at providing tertiary healthcare facilities among its residents including the city government employees;

WHEREAS, with the operation of the Ospital ng Muntinlupa, there is a need to expand the healthcare benefits, this time, to include out-patient services and diagnostic procedures which will prove to be a pro-active, preventive and cost-saving on the part of the City Government of Muntinlupa;

WHEREAS, there is a need to patronize and maximize the utilization of our own Ospital ng Muntinlupa;

NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panglungsod of Muntinlupa duly assembled the following:

SECTION I. Section 8 of Kautusang Bayan Bilang 93-31, entitled, "Muntinlupa Healthcare Program", which enumerates the healthcare benefits is hereby amended such that, item "a. Hospitalization" shall now read:

- a) "Hospitalization" at "out-patient consultation" at "laboratory procedures"
 - i) Pinakamataas (Maximum) na aabot sa Fifty Thousand Pesos (Php50,000) kung opisyal o kawani ay na-ospital o nagpakonsulta;
 - ii) Pinakamataas (Maximum) na aabot sa Twenty Five Thousand Pesos (Php25,000) kung lehitimong asawa ay na-ospital o nagpakonsulta.
 - iii) Pinakamataas (Maximum) na aabot sa Twenty Five Thousand Pesos (Php25,000) kung ibang dependents ang na-ospital o nagpakonsulta

SECTION II. Section 9 entitled "Mga Akreditadong Ospital" shall now read as follows:

Sinumang benepisyaryo na magkakasakit o magtatamo ng kapinsalaan, na dahil dito ay nangangailangan ng tertiary/specialty consultation ay ipa-konsulta o ipa-confine sa Ospital ng Muntinlupa na siyang nag-iisang akreditadong Ospital ng Komisyon.

SECTION III. Section 13 entitled, "Mga Kasali sa Pagkakaloob ng mga Serbisyo sa Health Care, will now read as:

- a.) Ospital ng Muntinlupa
- b.) Medical consultants, practitioners na nagpa-practice sa Ospital ng Muntinlupa.

SECTION IV. Section 14 entitled, "Hindi Kasama (Exclusion) will have an additional :

- g) "sadyang pagpapalaglag (induced abortion)"

SECTION V. Section 18 entitled, "Aproprasyon" - The entire second paragraph will be amended to read as follows:

"Ang Pamahalaang Lokal ay maglalaan ng pondong halagang anim (6) na milyon (P6,000,000) para sa pagbabayad ng healthcare services at apat (4) na milyon (P4,000,000) naman para sa medical loan benefit, na magkakabisa sa susunod na taong 2002 at maaari pang taasan sa mga susunod na taon kung kinakailangan".
