AN ORDINANCE GRANTING THE REQUEST OF THE OSPITAL NG MUNTINLUPA FOUNDATION, INC. FROM THE CITY GOVERNMENT OF MUNTINLUPA TO RELEASE THREE MILLION PESOS (Php 3,000,000.00) FOR THE OPERATION OF THE HOSPITAL.

WHEREAS, on March 29, 2001, the Contract for the Operation and Management of the Ospital ng Muntinlupa was executed between the City Government of Muntinlupa and the Ospital ng Muntinlupa Foundation, Inc.;

WHEREAS, the Contract, among others, provides that:

"4. Within a reasonable period from the signing of this Contract, the FIRST PARTY shall submit to the SECOND PARTY its:

- a. City Employees Health Care Program;
- b. Barangay Employees Health Care Program;
- c. Health Care Program of National Employees assigned in Muntinlupa, teachers, policemen, court and city prosecutors' employees;
- d. Socialized Health Care Program to residents of Muntinlupa City, who are issued with colored health cards;

These health care programs submitted shall form part of this Contract.

5. To assist the SECOND PARTY, the FIRST PARTY, thru the *Department of Social Welfare and Development*, shall designate or detail social workers or its equivalent, who shall evaluate and assess the paying capacity of the patients, who are availing of the socialized health care program of the City;

6. The **FIRST PARTY**, shall allocate in its annual Executive Budget it determines is sufficient to cover the hospitalization of its health care programs in paragraph 4 hereinabove;

7. The **SECOND PARTY** shall bill the **FIRST PARTY** of the hospitalization expenses of the patients covered by the health care programs of the City and the **FIRST PARTY** shall pay. Payments shall be taken from the allocation for the purpose in the **Annual Executive Budget**;

8. The **FIRST PARTY**, from time to time, shall continue to submit to the **SECOND PARTY** list of colored card bearing residents of Muntinlupa entitled to the socialized health care program;"

WHEREAS, the Hospital will start delivering In-Patient services on **October 29, 2001**;

WHEREAS, the Ospital ng Muntinlupa Foundation, Inc., requested the City Government of Muntinlupa to grant them an advance fund of **Three Million Pesos (Php 3,000,000.00)** that they could use for its operation;

WHEREAS, the City Government agrees provided that the billings of the patients availing of the program referred to in paragraphs 4, 5, 6, 7 and 8 mentioned above shall be deducted from the said amount and be considered as payment for the said billings until the total amount of **Three Million Pesos (Php 3,000,000.00)**, shall be fully used;

WHEREAS, the Ospital ng Muntinlupa Foundation, Inc., shall inform through writing the City Government from time to time the billings of the patients applied/ deducted from the **Three Million Pesos (Php 3,000,000.00)**;

WHEREAS, the billings of the Ospital ng Muntinlupa Foundation Inc., to the City Government shall be in accordance with **Ordinance No. 01-0017**, known as the **Kalingang Kalusugan Program of Muntinlupa and Ordinance No. 01-0018**, known as, **Health Care Program of the City Government Employees**, copies of which are hereto attached and made as integral parts of this Ordinance;

WHEREAS, the amount of **Three Million Pesos (Php 3,000,000.00)**, shall be taken from the Health Care Program provided for in the **Executive Budget of 2001**;

WHEREAS, the amount of **Three Million Pesos (Php 3,000,000.00)** to be released to the Ospital ng Muntinlupa Foundation, Inc. shall be subject to the Rules and Regulations of the Commission of Audit (COA).
