WHEREAS, under the Local Government Code of 1991 as amended the City Council has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the City funds.

WHEREAS, Ordinance No. 01-025 was passed and approved on November 22, 2001 during the Regular Session of the City Council;

WHEREAS, due to the inadvertence, the Team Leader of the Kabalikat with P2,500.00 additional allowance and the Rural Improvement Center for Children with additional allowance of P2,000.00 were not included, the Barangay Health Workers' additional allowance was made P2,000.00 when it should only be P1,000.00;

WHEREAS, due to economic crisis now, the Kabalikat, Team Leader of the Kabalikat, Rural Improvement Center for Children, SP Researchers, Joint Resources Family Program, Members of the Dance Company, Members of the City Band, Part-time Instructors of the MPC and Barangay Health Workers need to be granted with additional allowance as follows:

NOW THEREFORE BE IT ORDAINED, by the Sangguniang Panlungsod of Muntinlupa to grant additional allowance to the KABALIKAT, Team Leader of the Kabalikat, Rural Improvement Center for Children, SP Researchers, Joint Resource Family Program, Members of the Dance Company, Members of the City Band, Part Time Instructors of the MPC and Barangay Health Workers.


