WHEREAS, *Alsgrow Industrial and Development Corporation* is applying for an Alteration of Plan of its drainage system for the Bayfair of Margana Subdivision located at Putatan, Muntinlupa City;

WHEREAS, *Alsgrow Industrial and Development Corporation* already applied for alteration of plan of the road lot and the same was approved by the Sangguniang Panlungsod thru *Resolution No. 01-307* dated 31<sup>st</sup> of January, 2001;

WHEREAS, the original drainage plan as approved would have traversed from Soriano compound going towards Poblacion-Putatan river;

WHEREAS, the proposed new drainage plan will traverse from Damolo property going towards the same river;

WHEREAS, the reasons for the alteration are:

- a. Lesser cost because the distance is much shorter. The length before was 420 linear meters, as compared to the present length of 370 linear meters.
- b. The previous elevation was much lower (97.50 meters) and the new elevation 99.48, or almost a difference of two meters.


