WHEREAS, Alsgrow Industrial and Development Corporation is applying for an Alteration of Plan of its drainage system for the Bayfair of Margana Subdivision located at Putatan, Muntinlupa City;

WHEREAS, Alsgrow Industrial and Development Corporation already applied for alteration of plan of the road lot and the same was approved by the Sangguniang Panlungsod thru Resolution No. 01-307 dated 31st of January, 2001;

WHEREAS, the original drainage plan as approved would have traversed from Soriano compound going towards Poblacion-Putatan river;

WHEREAS, the proposed new drainage plan will traverse from Damolo property going towards the same river;

WNEREAS, the reasons for the alteration are:

a. Lesser cost because the distance is much shorter. The length before was 420 linear meters, as compared to the present length of 370 linear meters.

b. The previous elevation was much lower (97.50 meters) and the new elevation 99.48, or almost a difference of two meters.
