AN ORDINANCE EXTENDING THE DEADLINE FOR THE FILING /RENEWAL OF BUSINESS PERMITS AND THE PAYMENT OF ALL LOCAL BUSINESS TAXES, FEES AND OTHER CHARGES WITHOUT PENALTIES OR SURCHARGES FROM JANUARY 21 - FEBRUARY 16, 2001.

WHEREAS, Section 167 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that:

"Section 167. Time of Payment – Unless otherwise provided in this Code, all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees or charges without surcharges or penalties but only for a period not exceeding six (6) months".

WHEREAS, in view of Section 167 of R.A. 7160 and in view of the economic difficulties, the City Government of Muntinlupa should lend a helping hand to ease the burden over the shoulders of the taxpayers;

WHEREAS, the imposition of surcharges and penalties on unpaid taxes, charges or fees provided for under Section 169 of Ordinance No. 93-35, otherwise known as the Muntinlupa Revenue Code, will unduly cause financial burden on the part of the local businesses and cause unwarranted difficulties to our constituents of Muntinlupa, who are already suffering from the effects of escalating prices of goods and services;

NOW, THEREFORE, BE IT ENACTED by the Sangguniang Panlungsod duly assembled to extend the deadline for the filing/renewal of business permits and payment of all local business taxes, fees and other charges without penalties or surcharges from January 21 - February 16, 2001;
