WHEREAS, Section 167 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that:

*"Section 167. Time of Payment- Unless otherwise provided on this Code, all local taxes, fees, and charges shall be paid within the first twenty (20) days of January or each subsequent quarter, as the case may be. The Sanggunian concerned may, for a justifiable reason or cause, extend the time of payment of such taxes, fees, or charges without surcharges or penalties but only for a period not exceeding six (6) months".*

WHEREAS, in view of Section 167 of R.A. 7160 and in view of the economic difficulties, the City Government of Muntinlupa *should lend a helping hand* to ease the burden over the shoulders of the taxpayers;

WHEREAS, the imposition of surcharges and penalties on unpaid taxes, charges or fees provided for under *Section 169 of Ordinance 93-35* otherwise known as the *Muntinlupa Revenue Code* will unduly cause financial burden on the part of the local businesses and cause unwarranted difficulties to our constituents of Muntinlupa, who are already suffering from the effects of escalating prices of goods and services;

EFFECTIVITY. This ordinance shall have **retroactive effect** commencing on January 20, 2002 until the given extension period.
