**WHEREAS**, there is a need to create a body that would formulate a comprehensive plan, implement and monitor the City's rabies prevention and control program;

**SECTION 1.** The *Muntinlupa Rabies Prevention and Control Council* is hereby established.

**SECTION 2.** The *Muntinlupa Rabies Prevention and Control Council* shall be composed of the following:

1. *The City Mayor – Chairman*
2. *The Vice-Mayor – Vice Chairman*
3. *Chairman, Committee on Health and Sanitation – Member*
4. *Chairman, Committe on Agriculture, Fisheries, Environment and Natural resources-Member*
5. *Chairman, Committe on Public Order and Safety-Member*
6. *City Agricultural Officer-Member*
7. *City Health Officer-Member*
8. *Licensed Veterinarian-Member*
9. *1 Representative from Homeowners Association-Member*
10. *1 Representative from People’s Organization or Non Governmental Organization– Member*

**SECTION 3.** The MRPCC has the following duties and responsibilities:

1. *To formulate a long-term and comprehensive program on the prevention and control of rabies in the City of Muntinlupa.*
2. *To assist in the implementation and monitoring of the different anti-rabies programs.*
3. *To review policies, resolutions and ordinances pertinent to the program on rabies prevention and control; and to recommend amendments and passage of resolutions, ordinances for the furtherance of the program.*
4. *To coordinate with the different local agencies (i.e. City Health Office and City Agriculture Office) and National Offices (i.e. Department of Health (DOH), Department of Agriculture(DA), and Bureau of Animal Industry(BAI) ) concerned in the implementation of the programs.*

**SECTION 4.** *Effectivity Clause.* This ordinance shall take effect upon its approval.

ENACTED, by the *Sangguniang Panlungsod of Muntinlupa* this 28<sup>th</sup> day of February, 2002, on its 23<sup>rd</sup> Regular Session.
