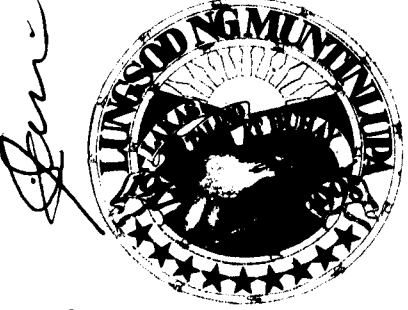
WHEREAS, another alteration is the establishment of a new right of way between **Block 5 Lot 6** and **Block 5 Lot 7** of the said plan;
