WHEREAS, *Republic Act No. 9048*, an amendatory law for **Articles 376 and 412** of the **Civil Code of the Philippines**, provides authority to the *City/Muntinlupa Civil Registrar*, the *Consul General* including the *Clerk of the Shari'a Court* in his capacity as District or Circuit Registrar of Muslim Marriages, Divorces, Revocations of Divorces and Conversions to correct a clerical or typographical error in an entry and/or change of first name or nickname in the civil register/civil document without need of judicial order;

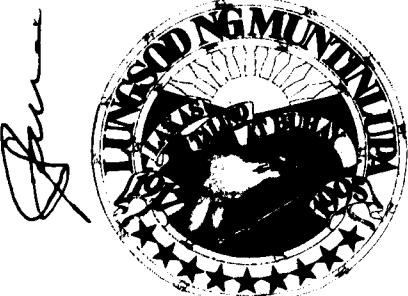
WHEREAS, *Rule 18 of Administrative Order No. 1, Series of 2001, Rules and Regulations Governing the Implementation of R.A. 9048*, provides authority to the City/Muntinlupa Civil Registrar or the District or Circuit Registrar of the Sharia' Court to collect from every petitioner a filing fee in the amount of **One Thousand Pesos (P1,000.00)** for the *correction of clerical or typographical error* and **Three Thousand Pesos (P3,000.00)** for *change of first name or nickname*. An indigent petitioner as defined under **Rule 2.7** of the same Order, shall be exempt from the payment of said fees, In the case of a migrant petitioner of clerical or typographical error, there shall be a service fee of **Five Hundred Pesos (P500.00)** to be collected by the petition-receiving Civil Registrar and service fee of **One Thousand Pesos (P1,000.00)** for change of *name or nickname*. The service fee shall accrue to the City or Municipal Government of the petition-receiving Civil Registrar;

WHEREAS, *Rule 18 of Administrative Order no. 1, Series of 2001*, further provides that the local legislative body shall ratify the fees prescribed and that prior to the ratification by the local legislative body, all fees collected in connection with this Order shall go to the trust fund of the Local Civil Registry Office;

NOW, THEREFORE, be it enacted by the City Council of Muntinlupa:

SECTION 1. *Imposition of fees* - The following fees shall be collected for services rendered by the Civil Registry in relation to the implementation of R. A. No. 9048:

- a. *Filing fee for correction of clerical or typographical error* P1,000.00
- b. *Filing fee for change of first name or nickname* P3,000.00
- c. *Service fee for migrant petitioner filing a petition for Correction of clerical or typographical error* P 500.00
- d. *Service fee for migrant petitioner filing a petition for change of name or nickname* P1,000.00
- e. *Indigent petitioner shall be exempt from payment of above fees provided, however, he/she is certified as such by the social welfare and development office of the city/municipality government;*

SECTION 2. The filing and service fees collected from the petitions for correction of typographical or clerical error in an entry and/or change of first name or nickname shall accrue to the account of the City Government.

SECTION 3. *Repealing Clause.*- All rules and regulations or any part thereof, in conflict or inconsistent with the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 4. *Effectivity.* This ordinance shall take effect immediately.

ENACTED, by the *City Council of Muntinlupa* on 27<sup>th</sup> day of June 2002, on its 37<sup>th</sup> Regular Session.




