AN ORDINANCE ALLOCATING TWO MILLION THREE HUNDRED THOUSAND PESOS (Php 2,300,000.00) TO BE USED IN THE PURCHASE OF COCONUT LUMBERS FOR DISTRIBUTION TO AFFECTED FAMILIES AND IN THE REPAIR, PATCHING OR ASPHALTING OF ROADS THAT ARE BEING DAMAGED BY HEAVY RAINS WHICH AMOUNT SHALL BE TAKEN FROM THE CALAMITY FUND.

WHEREAS, Section 458 (a) (1) (iv) of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Panlungsod to enact ordinances, approve resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:

(iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;

WHEREAS, Resolution No. 02-140 was passed by the Sangguniang Panlungsod of Muntinlupa "A resolution declaring the lakesides, shorelines, creek sides and other—low-lying areas of Muntinlupa to be under a state of calamity and authorizing the City Mayor Hon. Atty. Jaime R. Fresnedi for the immediate release of Calamity Funds";

WHEREAS, the frequent and continuous heavy rains are causing floods within the City of Muntinlupa specially in the areas near the Laguna de Bay;

WHEREAS, the flooding due to the continuous heavy rains affects the residents along the Laguna De Bay and causes damage to the roads within the city;

WHEREAS, due to the above situation, there is an urgent need to purchase and distribute coconut lumbers to affected families; for the relief operation of affected families; to repair, patch or asphalt the roads that are being damaged by the continuous heavy rains;

RESOLVE, THEREFORE AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled to allocate the amount of Two Million Three Hundred Thousand Pesos (P2,300,000.00) for the purchase of coconut lumbers to be distributed to affected families and for the repair, patching or asphalting of roads that are being damaged by the floods caused by the continuous heavy rains, which amount shall be taken from the Calamity Fund.
