AN ORDINANCE GRANTING THE PRELIMINARY APPROVAL FOR LOCATIONAL CLEARANCE (PALC) AND DEVELOPMENT PERMIT OF THE SUBDIVISION PLAN OF BRITTANY CORPORATION FOR ITS LA POSADA RESIDENTIAL SUBDIVISION LOCATED AT SUCAT, CITY OF MUNTINLUPA.

WHEREAS, Brittany Corporation is applying for Preliminary Approval for Locational Clearance and Development Permit for its La Posada Residential Subdivision located at Sucat, City of Muntinlupa;

WHEREAS, City Ordinance No. 91-39 grants the Sangguniang Panlungsod the power to approve subdivision plans;

WHEREAS, under Executive Order No. 71 and Republic Act No. 7160 otherwise known as the New Local Government Code of 1991, states that, "the power of the Housing and Land Use Regulatory Board (HLURB) to approve preliminary and final subdivision plans of all subdivisions has been transferred to the Local Government Units";

WHEREAS, under the said New Local Government Code of 1991, specifically under Section 458 (2)(x), states that, "the Sangguniang Panlungsod has the power to process and approve land use and zoning within its jurisdiction";

WHEREAS, after evaluating the necessary documents submitted by Brittany Corporation and based on the recommendation of the City Zoning Administrator, the application for Preliminary Approval for Locational Clearance and Development Permit of the proposed La Posada Residential Subdivision is hereby approved, subject to the terms and conditions under this ordinance;

NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the Sangguniang Panlungsod of Muntinlupa herein assembled that:

SECTION 1. The La Posada Residential Subdivision shall cover a total land area of 64,387.13 square meters located at Barangay Sucat, City of Muntinlupa.

SECTION 2. The developer, Brittany Corporation, shall comply with Section 18 of the Urban Development and Housing Act (UDHA) on Socialized Housing.

**SECTION 3.** The developer shall construct its own drainage system based on the revised drainage plan of the Right of Way (ROW) for the La Posada Residential Subdivision and shall not interconnect its drainage system with that of Posadas Subdivision.

**SECTION 4.** Any violation of the terms and conditions of this ordinance and other laws rules and regulations and permits of other government agencies and the documents submitted shall cause the **revocation of this ordinance**.

ENACTED by the Sangguniang Panlungsod of Muntinlupa this 25<sup>th</sup> day of July 2002, on its 41<sup>st</sup> Regular Session.
