ORDINANCE NO. 02-057

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P3,000.00) TO EVERY HOMEOWNER, TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, BOARDER, SHARER OF THE HOUSES BURNED BY THE FIRE ON AUGUST 9, 2002 IN PUROK 4, EXTENSION, ALABANG AND ARCIAGA COMPOUND, PUTATAN, MUNTINLUPA CITY.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:

(1)(iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on August 9, 2002, there were thirty (33) homeowners, ten (10) renters/boarder and one (1) sharer, who were affected by the fire in Purok 4 Extension, Alabang and Arciaga Compound, Putatan, Muntinlupa City;

WHEREAS, the owners of the houses, renters, sharers, and boarders, were rendered homeless by reason of the said fire;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of One Hundred Twenty One Thousand Pesos (P121,000.00) to be distributed as follows:

WHEREAS, the Social Services Department of the City has submitted a certified copy of the list of the homeowners, renters, sharers, and boarders in coordination with the Barangay Chairman of Alabang Hon. Victor L. Ulanday and shall be made an integral part of this ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the Executive Budget of the city;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled to grant three thousand pesos (P3,000.00) to each homeowner and two thousand pesos (P2,000.00) to each renter, boarder and sharer of the houses burned due to fire on August 9, 2002 in Purok 4, Extension, Alabang and Arciaga Compound, Putatan, Muntinlupa City, and allocating a total amount of *One Hundred Twenty One Thousand Pesos* (P121,000.00), which amount shall be taken from the 2002 Executive Budget – Calamity Fund.

APPROVED, by the Sangguniang Panlungsod of Muntinlupa this 15th day of August 2002, on its 43rd Regular Session.
