WHEREAS, last *January 21, 2002* at around *8:30 p.m.*, a bombing incident occurred along *Montillano St. at the Alabang Public Market* which brought about fear in our constituents;

WHEREAS, the bombing incident occurred at a time the City Government is having an intensive campaign against illegal vendors and other obstructions in the free flow of traffic;

WHEREAS, the said incident injured at least thirty (30) civilians and claimed three lives, one of whom is *NOEL NAVARRO*, an enforcer of the Traffic Environment and Discipline (TED);

WHEREAS, *NOEL NAVARRO* was on his duty when the bombing incident occurred and he showed his gallantry or heroism and dedication to his job even if it cost him his own life;

WHEREAS, *NOEL NAVARRO* being a public servant devoted to his belief, principle and job is a pride of the City of Muntinlupa;

WHEREAS, the loss of a loved one is tragic and even more excruciating for he is a public servant dedicated to his job;
