WHEREAS, under the Local Government Code of 1991 as amended, the City Council has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the City funds;

WHEREAS, due to high cost of living, the City Government finds it necessary to give additional allowance to the following employees:

| Barangay Health Workers                      | - one (1) month salary / allowance; |
| Part time instructor of the MPC              | - P5,000.00                         |

WHEREAS, this allowance shall be given on or before December 2002 and before or in December every year thereafter. When fund, allows one-half ( 1/2) of this additional allowance maybe given on or before June of every year, beginning in 2003;

WHEREAS, the payment for the allowance for this year shall be taken from the 2002 Executive Budget;




