WHEREAS, Resolution No. 02-149, mandates the creation of an Interim Market Committee whose primordial function and duty is to control, manage and supervise the operation of the New Muntinlupa Public Market;

WHEREAS, in connection with and as a lawful incident of the operation of the New Muntinlupa Public Market by the Interim Market Committee, there will be, collected and imposed, reasonable market fees and rentals from the market vendors, pursuant to **Resolution No. 02-150**;

WHEREAS, the fees and rentals to be collected from the market vendors shall be deposited in the name and for the account of the City Government of Muntinlupa as a "Trust Account", part of which shall be drawn the expenses relative to the operation, management, development and improvement of the public market;

WHEREAS, all the disbursement shall follow the usual Accounting rules and procedures of the City Government of Muntinlupa;

NOW, THEREFORE, be it RESOLVED as it is hereby resolved, by the Sangguniang Panlungsod of Muntinlupa, authorizing the City Mayor, HON. ATTY. JAIME R. FRESNEDI, to open and maintain a separate account in the name of the City of Muntinlupa from the funds that will be generated from the operation of the New Muntinlupa Public Market.
