WHEREAS, on *January 17*, 2002 an Ordinance No. -02-035 was passed by the City Council;

WHEREAS, the purposes and objectives of the Ordinance are clearly stated therein;

WHEREAS, the Ordinance is being enforced by the Traffic Enforcers in humane manner and that the same resulted in the issuance of Ordinance Infraction Receipts (OIR) to many truck drivers for violation of the Ordinance;

WHEREAS, the efficient enforcement of the Ordinance resulted in the declogging of the heavy traffic condition underneath Alabang Viaduct and the traffic condition in the area is now normal;

WHEREAS, on October 29, 2002 there was a public hearing conducted by the Committee of Public Order Security and Safety due to the request of Confederation of Truckers Associations of the Philippines, Inc. (CTAP), Jose Y. Cortes - President and Port Users Confederation, Inc. Noemi L. Saludo - President thru their letters dated October 10, 2002 and other groups and individuals, wherein they earnestly request for the suspension of the City Ordinance No. 02-035 and that they be allowed 24 hours passage on the Underneath Alabang Viaduct;

WHEREAS, during the public hearing, truckers and businessmen claimed that the Ordinance is causing late deliveries, causing contract cancellation, causing labor force leave and additional overhead expenses to businesses situated in Muntinlupa City and CALABARZON area and they suffer losses and enforcement of the Ordinance will result in the closure of their business establishments;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED by the Sangguniang Panlungsod to authorize Hon. City Mayor Atty. Jaime R. Fresnedi to suspend enforcement of the City Ordinance No. 02-035 beginning November 9, 2002 up to January 15, 2003.
