#### **ORDINANCE NO. 03-080**

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P3,000.00) TO EVERY HOMEOWNER (TOTALLY DAMAGED), TWO THOUSAND PESOS (P2,000.00) TO EACH RENTER, BOARDER, SHARER AND ONE THOUSAND PESOS (P1,000.00) TO EACH HOMEOWNER (PARTIALLY DAMAGED) OF THE HOUSES BURNED BY THE FIRE ON JANUARY 23, 2003 IN BLOCK 17, EXCESS LOT, SOLDIER'S HILLS, PUTATAN AND ON FEBRUARY 2, 2003 AT #208 BLOCK 7, PUROK 1, BAYANAN, MUNTINLUPA CITY.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall:

(1)(iv) Adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"

WHEREAS, on January 23, 2003 and February 2, 2003, there were sixty (60) homeowners (totally damaged), eighteen (18) renters/boarders/sharer, and ten (10) homeowners (partially damaged) who were affected by the fire in Block 17, Excess Lot, Soldier's Hills, Putatan, and # 208 Block 7, Purok 1, Bayanan, Muntinlupa City;

WHEREAS, the owners of the houses, renters, sharers, and boarders, were rendered homeless by reason of the said fire;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of Two Hundred Twenty Six Thousand Pesos

(P226,000.00) to be distributed as follows:

WHEREAS, the Social Services Department of the City has submitted a certified copy of the list of the homeowners (totally damaged), renters, sharers, and homeowners (partially damaged) in coordination with the Barangay Chairman of Putatan Hon. Danilo R. Teves is made an integral part of this ordinance;

WHEREAS, there is an available fund from the Calamity Fund in the 2003 Executive Budget of the City;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled to grant Three Thousand Pesos (P3,000.00) to each homeowner (Totally Damaged) and Two Thousand Pesos (P2,000.00) to each renter, boarder and sharer and One Thousand Pesos (P1,000.00) for each homeowner (partially damaged) of the houses burned due to fire on January 23, 2003, in Block 17, Excess Lot, Soldier's Hills, Putatan and # 208 Block 7, Purok 1, Bayanan, Muntinlupa City, and allocating a total amount of Two Hundred Twenty Six Thousand Pesos (P226,000.00), which amount shall be taken from the 2003 Executive Budget - Calamity Fund.

APPROVED, by the Sangguniang Panlungsod of Muntinlupa this 6th day of February 2003, on its 62<sup>nd</sup> Regular Session.
