WHEREAS, Section 13 (b) (1) of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that "The sanggunians of highly urbanized and of component cities and whose charters prohibit their voters from voting for provincial elective officials, hereinafter referred to in this Code as an independent component cities, may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:

(1) City barangays, upon recommendation of the Sangguniang barangay concerned;

WHEREAS, Barangay New Alabang (Ayala) was established in 1980 through Parliamentary Bill No. 1806 and by virtue of Section 3 of said bill, Mr. ENRIQUE ZOBEL was appointed by the then President Ferdinand E. Marcos as the Chairman of said Barangay;

WHEREAS, despite the adoption of its official name, the same is still being called as Barangay Ayala Alabang instead of Barangay New Alabang (Ayala);

WHEREAS, due to strong clamor of the residents of said barangay, Resolution No. 045, Series of 2002 was passed by the Sangguniang Barangay of New Alabang (Ayala) last November 18, 2002;

WHEREAS, there is a need to change the name Barangay New Alabang (Ayala) to Barangay Ayala Alabang to avoid confusion and be distinct from that of the adjacent

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Muntinlupa the following:

SECTION 1. This Ordinance hereby rename Barangay New Alabang to BARANGAY AYALA ALABANG.

SECTION 2. The Sangguniang Barangay of Ayala Alabang shall be required to pass a resolution adopting its new seal and logo for this purpose.

SECTION 3. Copies of this Ordinance shall be furnished to Barangay Ayala Alabang, Philippine Historical Institute, Muntinlupa Historical Commission and the Department of Interior and Local Government for its guidance and future reference.

SECTION 4. Any ordinance, resolution, decrees or part/s thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified 'accordingly.

SECTION 5. This Ordinance shall take effect immediately upon approval.
