WHEREAS, Ordinance no. 03-088 "An Ordinance granting Three Thousand Pesos (P3, 000.00) to every homeowner (totally damaged), Two Thousand Pesos (P2, 000.00) to each renters and sharers and One Thousand Pesos (P1, 000.00) to each Boarder and homeowner (partially damaged) of the houses burned by the fire on March 10, 2003 in Purok 3, PNR site, Cupang Muntinlupa City" was passed by the Sangguniang Panlungsod on March 13, 2003, on it's 66th Regular Session;

WHEREAS, on the said Ordinance there were only Thirty Six (36) homeowners (totally damaged), Forty Eight (48) renters listed who were affected by the fire in Purok 3, PNR site, Cupang, Muntinlupa City;

WHEREAS, the Social Services Department (SSD) provided an additional list of deserving family fire victims. *There is an additional One (1) homeowner (totally damaged) and One (1) renter affected;*

WHEREAS, *there is a need* for the City Government to give additional *Five Thousand Pesos (P5, 000.00)*, financial assistance to the additional victims *aside* from *Two Hundred Twenty Thousand Pesos (P220, 000.00);*

WHEREAS, the additional *Five Thousand Pesos (P5, 000.00)* shall be distributed as follows:

House owner (totally damaged)	36 + 1	P3,000.00	P111,000.00
Renters/sharers	48 + 1	P2,000.00	P 98,000.00
Boarders	14	P1,000.00	P 14,000.00
House owners partially damaged	2	P1,000.00	P 2,000.00
TOTAL AMOUNT:			P225,000.00
