WHEREAS, Pedro E. Diaz High School - Annex located in Barangay Buli, Muntinlupa City was established on June 7, 1999 to cater to the needs of our growing student population in District II.

WHEREAS, Pedro E. Diaz High School - Annex has graduated 278 pioneering 4th year high school students last April 10, 2003 and has become one of the fastest rising secondary educational institutions in the city;

WHEREAS, its status as a mere annex of the Pedro E. Diaz High School - main in Alabang has deterred it from making curricular innovations and pursuing its own vision and mission as an independent academic institution;

WHEREAS, the present economic environment and potential of the city as a new business hub in the National Capital Region (NCR) as well as its proximity to the CALABARZON area makes it an ideal business oriented secondary institution;

WHEREAS, the administration, faculty, studentry, and the community at large have supported the aim of the school to specialize in a business curriculum to further enhance the economic development of the city;

WHEREAS, the administration, faculty and staff commit to the fulfillment of the vision and mission of the Department of Education and the City Government of Muntinlupa in the delivery of quality and affordable basic education to its people;

WHEREAS, the establishment of the *Muntinlupa Business High School* is in accordance with the policy of the Department of Education to establish one business high school in each of the city and municipality of the country pursuant to RA No. 6655;

WHEREAS, the establishment of the school as an independent secondary institution will provide it a wider means of support from the National Government and the Department of Education as well as wider avenues for the administrators, faculty and staff, students, and the community for innovations and development;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session assembled that:

SECTION 1. The vision of the *Muntinlupa Business High School* shall be as a secondary school specializing in business education, It shall produce graduates with high sense of business orientation who are academically and intellectually prepared, humane and morally upright, entrepreneurial, self reliant, creative, innovative, environmentally conscious, highly responsible citizens, dynamic, resourceful, dedicated and committed.

**SECTION 2.** The objectives of Muntinlupa Business High School are:

1. Train the students to acquire skills, knowledge, processes and principles necessary in pursuing gainful business oriented career.

2. Provide students with opportunities to develop their business inclinations, entrepreneurship and leadership potentials

3. Help the students grow as responsible and well - rounded citizens who are aware and mindful of their social and moral duties and responsibilities towards God, family, fellowmen, community and country;

4. Guide the students to live a sustainable and fruitful life while co – existing with their fellowmen and while living harmoniously with nature;

SECTION 3. The *Muntinlupa Business High School* will offer a curriculum focused on preparing its graduates for college degrees leading to the following: entrepreneurship, management, marketing, commerce, industry, and media communications and practice among others.

**SECTION 4.** Muntinlupa Business High School shall be under the jurisdiction of the National Government through the Department of Education after its establishment. It shall be run and managed by the duly appointed personnel of the Department of Education.
