NOW, THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod of Muntinlupa herein assembled that:

Section 1. The Alteration of Plan of Lots 287-A, 287-B, and 287-C covering an area of 9,308 square meters located within San Jose Village in Alabang, Muntinlupa City shall be for purely residential purposes only.

Section 2. Any violation of the above terms and conditions shall be a ground for revocation of this Ordinance.
