WHEREAS, the Sangguniang Panlungsod of Muntinlupa passed Ordinance No. 03-100 granting the request of San Jose Realty and Development Corporation for the alteration of Lot 287-A, Lot 287-B and Lot 287-C located inside San Jose Village, Alabang, Muntinlupa City from "Market site" to purely residential area;

WHEREAS, San Jose Realty & Development Corporation is asking for alteration of its site development plan, specifically the relocation of the site of the swimming pool and the increase of the saleable units from 116 to 132 units;

WHEREAS, finding the documents submitted by San Jose Alabang Realty & Development Corporation to be in compliance with the requirements of the law, and based on the recommendation of the City Zoning Administration, the application for Alteration of its site development plan is hereby approved;

NOW, THEREFORE, BE IT ORDAINED as it is hereby ordained, by the Sangguniang Panlungsod of Muntinlupa herein assembled that: a new section shall be added to Ordinance No. 03-100, to wit:

Section 1. The total number of saleable units shall be increased and the site of the wimming pool shall be relocated based on the amended site development plan.
