AN ORDINANCE AMENDING ORDINANCE NO. 03-082 OTHERWISE KNOWN AS AN ORDINANCE ESTABLISHING THE MUNTINLUPA DRUG-RELATED NUISANCE BOARD (MDRNB), DEFINING ITS COMPOSITION, DUTIES AND RESPONSIBILITIES AND FOR OTHER PURPOSES.

WHEREAS, the Sangguniang Panlungsod of Muntinlupa passed and approved Ordinance No. 03-082, otherwise known as the 'AN ORDINANCE ESTABLISHING THE MUNTINLUPA DRUG-RELATED NUISANCE BOARD (MDRNB), DEFINING ITS COMPOSITION, DUTIES AND RESPONSIBILITIES AND FOR OTHER PURPOSES", on the 6th day of February, 2003 on its 62nd Regular Sessions;

WHEREAS, there is a need to strengthen said ordinance in order to meet its objective and to further make it more effective and relevant;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Members of the Sangguniang Panlungsod duly assembled the following amendments to the said Ordinance;

SECTION 1. Sections 3 and 10 of Ordinance No. 03-082 is hereby amended to and read as follows:

Sec. 3. Composition. The Muntinlupa Drug-Related Nuisance Board (MDRNB) shall be composed of the following:

1. City Health Officer

Chairperson

2. City Legal officer -

member

3. Local Chief of Police

member

4. Representative from the City Council preferably the Chairman on Committee on Public Order, Security and Safety – Member;

5. Representatives from the following sectors:

a. Religious Sector -

b. President or Chairman of Federation, Homeowners

> c. Representative of an educational sector Said representatives shall be appointed by the City Mayor whose appointment is final.

Section 10. Office. The Board and Secretariat shall have its Office at the Drug Abuse Prevention and Control Office (DAPCO) and will conduct meetings and hearings in a place to be determined by it;

Additional sections are created which shall become Sections 11 and 12 of Ordinance No. 03-082 to be read as follows:

"Section 11. Secretariat. The DAPCO will serve as the secretariat of the Board. The Secretariat shall have the following functions:

a. Receive all complaints and evidence for the complainants on a place being used as site for the unlawful sale and, delivery of dangerous drugs;

b. To recommend to the board on whether or not there is a probable cause against the respondent to warrant the hearing;

c. To conduct ocular inspection of the place or premises being used as unlawful sale and delivery of drugs or used as drug dens for pot sessions and other similar activities and to submit its finding or recommendation in writing within two (2) days upon receipt of the order;

d. To coordinate with other agencies and offices for the effective implementation and enforcement of all resolutions and ordinances dealing with drugs.

e. To be the custodian of all the records of the Board.

Section 12. Honoraria/Allowance. The Chairman and members of the MUNTINLUPA DRUG-RELATED NUISANCE BOARD (MDRNB), Drug Abuse Prevention and Control Office (DAPCO) and its staff may be given honoraria or allowances at the discretion of the City Mayor and upon availability of funds."

Sections 11 Support Services and 12 Effectivity Clause of Ordinance No. 03-082 become Sections 13 and 14 and that Section 13 Formulation of the Implementing Rules and Regulations will become section 14

SECTION 2. REPEALING CLAUSE. Any other ordinances, resolutions or parts thereof, which are inconsistent herewith, are hereby repealed or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE. If for any reason or reasons, any section or provision of this ordinance shall be held unconstitutional or invalid, no other section or provision thereof shall be affected thereby.

SECTION 4. EFFECTIVITY. This ordinance shall take effect after the signing of the City Mayor and publication in a newspaper of general circulation in the City of Muntinlupa.
