WHEREAS, the said tragic and unusual accident caused the lives of the nine\members of the group including a 9-year-old boy. Other victims survived but in serious condition, such as five and seven-year-old child who suffered fractured bones and were confined for several days at the hospital due to head trauma and serious injuries;

WHEREAS, some of those who were killed were residents of the City of Muntinlupa;

WHEREAS, there is a need to extend Five Thousand Pesos (P5,000.00) financial assistance to the nine (9) members of the Jesus is our Shield religious group who were killed in the said vehicular accide t;

WHEREAS, the fund shall be taken from any available fund of the 2003 Executive Budget.

NOW THEREFORE BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Panlungsod duly assembled, giving financial assistance to those residents of the City of Muntinlupa who were killed in a vehicular accident on November 1, 2003 at Mandaluyong City amounting to Five Thousand Pesos (P5,000.00) each with a total amount of Forty Five Thousand Pesos (P45,000.00).
