AN ORDINANCE PROHIBITING PET OWNERS FROM INTENTIONALLY BRINGING OUT THEIR PETS TO URINATE AND DEFECATE ON STREETS AND SIDEWALKS.

WHEREAS, section 15, article II of the 1987 Philippine Constitution provides that, "The State shall protect and promote the right to health of the people and instill health consciousness among them";

WHEREAS, section 8.51, Chapter 9 of PD 856, otherwise known as the Sanitation Code of the Philippines states that: "There shall be no noxious matter or any harmful substance that shall be disposed of unto streets, roads, alleys, bodies of water, or in any path ways or places not approved by the local health officer";

WHEREAS, section 458 (a)(4)(viii) of RA 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Panlungsod to regulate activities relative to the use of land, buildings and structures within the City in order to promote the general welfare and for said purpose shall:

(viii) Regulate the keeping of animals in homes or as part of a business, xxx;

WHEREAS, section 458 (a)(5)(v) of the same Code, authorizes the Sangguniang Panlungsod to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places;

WHEREAS, it is a common practice of pet owners to intentionally bring out their ets to urinate and defecate on streets and sidewalks;

WHEREAS, scattered feces in front of every residence in the streets and sidewalks of subdivisions, villages and barangays are one of the source of conflicts or misunderstandings among neighbors in the community;

WHEREAS, there is a need to prohibit pet owners from intentionally bringing out their pets to urinate and defecate on streets and sidewalks in order to prevent the spread of harmful, disease-causing bacteria and obnoxious foul odor in the air, and to eliminate scattered feces as part of the Clean and Green Program of the City of Muntinlupa;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the members of the Sangguniang Panlungsod duly assembled the following:

Section 1. Prohibition. Pet owners are hereby strictly prohibited from intentionally bringing out their pets to urinate and defecate on streets and sidewalks.

**Section 2. Exception**. In case of unavoidable circumstances where pets urinate and/or defecate on streets and sidewalks beyond the owner's control and without intention on the part of the latter to bring out his/her pets for such purpose, the penalties provided for in this Ordinance shall not be imposed. However, the owner shall be responsible for the cleaning and/or removal of feces immediately afterwards.

**Section 3. Definition of Terms.** As used in this Ordinance, the following terms are hereby defined as follows:

a. Pets- any animal kept, fed within a person's house yard or premise

- b. Owner- any person keeping, harboring, having charged or control of pets.
- c. Defecate- to discharge feces or waste
- d. Urinate- to discharge urine
- e. Street- Any thoroughfare of public space which has been dedicated or deeded to the public for public use. The word street includes not only the roadway, which is used for carriages and vehicular traffic generally, but also the portion used for pedestrian travel.

f. Sidewalk- A part of the street which the authorities have set apart for the use of pedestrians.

**Section 4. Penalties.** Any person found violating this Ordinance shall be penalized as follows:

First Offense:

A fine of five hundred pesos (500 Php).

Second Offense:

A fine of one thousand pesos (1,000 Php) and one

(1) day community service.

> Third and Succeeding Offense:

A fine of two thousand pesos (2,000 Php) and five (5) days community service.

The penalties provided under this section shall include the cleaning and/or removal of animal feces on streets and/or sidewalks regardless of the number of times this Ordinance will be violated.

Section 5. Implementing Agency. The City Veterinarian Office shall be the implementing agency of this Ordinance.

Section 6. Support Services. Other government offices and agencies of the City of Muntinlupa are mandated to support this Ordinance.

Section 7. Repealing Clause. Any other ordinances, resolutions or parts thereof, which are inconsistent herewith, are hereby repealed or modified accordingly.

Section 8. Seperability Clause. If for any reason or reasons, any section or provision of this Ordinance shall be held unconstitutional or invalid, no other section or provision thereof shall be affected thereby.

Section 9. Effectivity. This Ordinance shall take effect immediately upon approval.
