WHEREAS, under the Local Government Code of 1991 as amended the City Council has the power to determine the positions, salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly and mainly from the City funds;

WHEREAS, due to economic crisis now the *Consultants Of Mayor's Office, Vice Mayor And Sp Researcher, Team Leaders And Members Of Kabalikat, Joint Resources For Family Program (JRF), Rural Improvement Center For Children (RIC) Barangay Health Workers, Member Of Brass Band, Members Of Dance Company,* need to be granted with additional allowance in the amount of One Thousand Pesos each;

WHEREAS, there are 2,119 employees qualified, out of our total work force of 3,821 employees;

WHEREAS, the application for this payment is based on the two preceeding semesters, qualification is based on employees hired on or before January 2, 2002 and must be in active service as of December 1, 2003;

WHEREAS, there are 1,702 exemptions as follows: Consultants (25), SP Researchers (109), Kabalikat (699), JRF (90), RICC (13), BHW (228), City Band (51), Dance Company (7) and Hired after January 2, 2003 (480);

WHEREAS, to grant a P1,000.00 payment each for the 1,222 employees in the spirit of the season and in appreciation of their continued support to our city programs;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, granting additional allowance to the Consultants of Mayor's Office, Vice Mayor and SP Researcher, Team Leaders and Members of Kabalikat, Joint Resources for Family Program (JRF), Rural Improvement Center For Children (RICC), Barangay Health Workers, Member of Brass Band, Members of Dance Company.







