ORDINANCE NO. 03-124

AN ORDINANCE GRANTING THREE THOUSAND PESOS (P 3,000.00) TO EVERY HOMEOWNER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND TWO THOUSAND PESOS (P 2,000.00) TO EACH RENTER, BOARDER, SHARER (WHOSE HOUSE WAS TOTALLY DAMAGED) AND ONE THOUSAND PESOS (P1,000.00) EACH RENTER, BOARDER AND SHARER (WHOSE HOUSE WAS PARTIALLY DAMAGED) BY THE FIRE ON DECEMBER 23, 2003 AT PUROK 4, CUPANG AND #242 ARANDIA ST., TUNASAN, MUNTINLUPA CITY, WHICH AMOUNT SHALL BE TAKEN FROM THE EXECUTIVE BUDGET – CALAMITY FUND.

WHEREAS, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

*"(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events;"*

WHEREAS, on December 23, 2003, there were eleven (11) homeowners (whose houses were totally damaged), ten (10) renters (whose houses were totally damaged) and three (3) boarders/sharers (whose houses were totally damaged) who were affected by the fire in Purok 4, Cupang and #242 Arandia St., Tunasan, Muntinlupa City;

WHEREAS, the owners of the houses, renters, sharers, and boarders, were rendered homeless by reason of the said fire;

WHEREAS, there is a need for the City Government to give financial assistance to the aforesaid victims in the amount of **Fifty Five Thousand Pesos (P55,000.00)** to be distributed as follows:

Homeowners (totally damaged houses) (11) - P3,000.00 each – P 33,000.00

Renters (totally damaged houses) (8) - P2,000.00 each – P 16,000.00

**WHEREAS**, the Social Services Department of the City has submitted a certified copies of the list of the homeowners (whose houses are totally damaged) and renters, sharers in coordination with the Barangay Chairman of Cupang - **Hon. Artemio A. Simundac** and Barangay Chairman of Tunasan - **Hon. Manuel P. Solomon** which are made as an integral parts of this ordinance;

**WHEREAS**, there is an available fund from the Calamity Fund in the Executive Budget of the City;

**RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED**, by the Members of the Sangguniang Panlungsod duly assembled to grant **Three Thousand Pesos (P3,000.00)** to each homeowner (whose houses were totally damaged), **Two Thousand Pesos (P2,000.00)** to each renter, boarder and sharer and **One Thousand Pesos (P1,000.00)** each renter, boarder and sharer (whose houses were partially damaged) of the houses burned due to fire on December 23, 2003, Purok 4, Cupang and #242 Arandia St., Tunasan, Muntinlupa City, and allocating a total amount of **Fifty Five Thousand Pesos (P55,000.00)**, which amount shall be taken from the Executive Budget - Calamity Fund.

**APPROVED**, by the *Sangguniang Panlungsod of Muntinlupa* this 8<sup>th</sup> day of January 2003, on its 99<sup>th</sup> Regular Session.




