WHEREAS, for lack of material time and pending the submission of necessary documents the Committee has yet to submit its recommendations;

WHEREAS, Mr. Alberto Suansing and Mr. Jose Y. Cortes, of the Confederation of Truckers Association of the Philippines, Inc. (CTAP), thru a letter dated January 14, 2003 requested the City Council of Muntinlupa thru Honorable City Mayor, Atty. Jaime R. Fresnedi, to extend moratorium on the implementation of City Ordinance No. 02-035 up to January 31, 2003 and the further studies on the matter of the coverage of the MMDA Truck Ban;
