WHEREAS, on November 7, 2002 a Resolution No. 02-171 was passed by the City Council;

WHEREAS, the purposes and objectives of said Resolution are clearly stated therein;

WHEREAS, said Resolution authorized the Honorable City Mayor, Atty. Jaime R. Fresnede, to suspend Ordinance No. 02-035 beginning November 9, 2002 until January 15, 2003;

WHEREAS, on January 10, 2003 a public hearing was conducted by the Committee of Public Order Security and Safety to find out whether or not the Ordinance will be enforced again or amendments will be made;

WHEREAS, for lack of material time and pending the submission of necessary documents the Committee has yet to submit its recommendations;

WHEREAS, Mr. Alberto Suansing and Mr. Jose Y. Cortes, of the Confederation of Truckers Association of the Philippines, Inc. (CTAP), thru a letter dated January 14, 2003 requested the City Council of Muntinlupa thru Honorable City Mayor, Atty. Jaime R. Fresnede, to extend moratorium on the implementation of City Ordinance No. 02-035 up to January 31, 2003 and the further studies on the matter of the coverage of the MMDA Truck Ban;






