WHEREAS, the owners of the houses, renters, sharers and boarders, were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas in a state of calamity;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last January 23, 2003 and February 2, 2003 at Block 17, Excess Lot, Soldier's Hills, Putatan, Muntinlupa City And 208 Block 7, Purok 1, Bayanan, Muntinlupa City be declared as in a state of calamity.
