RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the *Members of the Sangguniang Panlungsod* duly assembled that the area affected by the fire last **March 10, 2003** at Purok 3, PNR Site, Cupang, Muntinlupa City *be declared as in a state of calamity.*
