**WHEREAS**, one of the priority programs of the City Government of Muntinlupa is the improvement of Garbage Collection and Disposal Services in order to ensure the cleanliness of the entire city;

**WHEREAS**, in order to attain this objective, the City Government published in the newspaper of general circulation, invitation to pre-qualify and to bid on **May 12, 16 and 20, 2003**;

**WHEREAS**, in the **Public Bidding** held on **June 11, 2003** in the Office of the City Treasurer, City Hall Building, Muntinlupa City, REN Transport Corporation offered the lowest bid of **Six Million Four Hundred Seventy Nine Thousand Five Hundred Fifty One Pesos and Fifty Centavos (P6,479,551.50)** monthly and was recommended to be awarded with the Contract for the Garbage Collection and Disposal Services by the Pre-qualification, Bids and Awards Committee, pursuant to a Resolution dated **June 16, 2003**;

**WHEREAS**, there is a fund allocation in the 2003 Executive Budget of the City for the period **July to December, 2003** and the budget in the year 2004 shall be allocated in the Executive Budget next year,

**WHEREAS**, the Contract is effective **July 1, 2003 to June 30, 2004**;


