NOW THEREFORE, BE IT RESOLVE AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, to approve the 2003 Supplemental Budget amounting to **Thirty Eight Million, Two Hundred Four Thousand, Eight Hundred Fifty Six Pesos (Php38,204,856.00)**.


