WHEREAS, on September 17, 2003, there were three hundred seventy-two (372) homeowners (totally damaged), two hundred eleven (211) renters/sharers and thirty-five (35) boarders that were affected by the fire in Purok 8, Joaquin Compound and Bautista Compound PNR Side Alabang, Muntinlupa City;

WHEREAS, the owners of the houses, renters, sharers and boarders, were rendered homeless by reason of the said conflagration;

WHEREAS, the Social Services Department recommended to declare the affected areas in a state of calamity;

RESOLVE, THEREFORE, AS IT IS HEREBY RESOLVED, by the Members of the Sangguniang Panlungsod duly assembled that the area affected by the fire last September 17, 2003 at Purok 8, Joaquin Compound and Bautista Compound, PNR Side Alabang, Muntinlupa City be declared as in a state of calamity.
